



## Clifton Day Kids' Booth Application 2024

Clifton Day is Sunday, October 13, 2024 from 9am to 5pm (with NO rain date). The Clifton Betterment Association (CBA) will allow kids to have a booth to sell some of their own wares.

In order to have any Kids' Booths at Clifton Day:

1. One parent must agree to remain in the Kids' Booths area to supervise. Supervising parents have the responsibility to make sure that all kids comply with the rules. No automobiles are allowed in town after 8 am and are not allowed to return until after 5 pm. Tables, chairs and sales items must be brought into town within these time constraints, unless you can find a private property owner that will allow you to store equipment. Carpooling is encouraged.
2. Kids and parents must participate in Saturday general set up for Clifton Day and/or Monday clean up and break down. Set up crews meet at 8 am the day before Clifton Day (Saturday) at the barn. Clean up crews meet at 9 am Monday, the day after Clifton day at the General Store or barn. (Remember to bring gloves.) Adults and pick up trucks are especially important at both times.
3. All participants must be CBA members or a Clifton Girl/Boy Scout troop. Membership in the CBA is geographically limited to residents of the former Clifton Elementary school district.
4. There will be no fireworks, no noise makers, no stink, smoke or flour bombs, no weapons, and no trash makers. No confetti or string. No drinks, food, gum, or candy without prior arrangement with the CBA. No political items or parent's business items. Handmade crafts are encouraged. No garage sales to clean out your house, although used toys and kids items are allowed.
